LESSONS

- Classes during the year are split over TWO TERMS
- TERM1 (January – May) 37 Lessons and TERM2 (August- middle December) 37 Lessons.
- **Two lessons per week, each lasting a half hour.**
- There will be swimming classes during March school holidays.
- If however these classes are missed there will be no catch-up lessons.
- We are only closed one week in OCTOBER from the 1st to the 7th of OCTOBER.
- No swimming classes will take place on public holidays, and there will be no catch-up session for those days.
- Children will be picked up at school and dropped off after the swimming lessons.
- ALL DRIVERS HAVE A VALID PROF. DRIVING PERMIT “PDP”
- If you want to bring your child yourself for lessons, in the afternoons, other times are available.
- It will however still remain your responsibility to look after your child, especially near open pools or other water source!

KIT / ACCESSORIES

- Own towel and swimming clothes
- **If swimming wear is not at school, the child will not be picked up for lessons**

PRIZE GIVING

Every end of a swimming term there will be an examination. This will take place on a Saturday to enable the parents to see how their child is performing..

More information regarding the exam will be given to you in time to make arrangements.

HOW TO START SWIMMING

- **If you are interested, an application form must be handed in at your school or at the swimming school.**
- **Ensure to sign the back of the application form....NB!**
- **To prevent any disappointment on your side, you must act as soon as possible, since only a limited number of children can be accommodated.**

Registration Fee R250 Once-off

TERM 1: 10 JAN - 28 MAY = R3750 + R250 REGISTRATION ONCE-OFF

TERM 2: 1 AUG - 15 DEC (IF YOU ATTENDED JAN TO MAY) = R3750

2 Options to pay your child's swimming fee:

OPTION 1: Term 1 fees of R3750 + R250 can be paid once off in Jan.
Term 2 fees of R 3750 can be paid once off in Aug.

OPTION 2: Term fees of R3750 can be paid monthly **[R750 monthly]**
The 5 instalments that must be made in-advance before or on the 1st of each month.

GENERAL TERMS AND CONDITIONS.

1. Classes

- o Classes during the whole year are split over 2 terms.
- o Parents may not bring learners to the pool in school lessons.
- o TERM 1 (January – May) TERM 2 (August- middle December). NO FEES JUNE AND JULY
- o There will be class irrespective of weather conditions (except lightning), since the swimming pool is indoors and heated.
- o WE TAKE NO RESPONSIBILITY FOR LOST/STOLEN BELONGINGS

2. Lessons

- The R750 option will give you 38 lessons between 10 January and 28 May.
- The R520 option will give you 17 lessons between 10 January and 28 May.
- The R620 option will give you 17 lessons between 10 January and 28 May.
- However if classes are missed there will be no catch-up lessons.
- No swimming lessons will take place on public holidays, and there will be no catch-up lessons for those days.

3. Payment of Fees

- Fees are strictly payable in advance and it's monthly payments so must be paid no later than the 1st of each month.
- **PLEASE NOTE: Should you fail to pay your account as indicated, a friendly reminder will be sent to you. If such an amount in arrears is not paid within three days, coaching will be suspended as of the 7th of the month. Coaching will only resume after the remaining outstanding fee for the whole term is paid. No credit will be given.**
- No reduction of fees for non-attendance due to Illness/ Covid-19 or any other reason.
- All queries concerning accounts must be directed to the office, this will insure you of prompt response.
